Respected sin of Madam

In continuation with my DO letter dated 8th April, 2019 in respect of engaging services of CSC, following activities may be immediately undertaken and the progress/ finalization may please be intimated to IT and ER division.

- 1. Agreement and NDA copy signed between CEOs and CSC. If not done till now, may please be expedited immediately.
- 2. The Nodal Officer for CSC be identified and assigned a role to monitor and educate BLES' Assistant at central level about ER operation and EVP tasks expected from them to be done on National database through their secure login and OTP.
- There are three ways of Notational data access through ERO Net login by CSC.
 - The Nodal Officer can be provided API and login credential using which he can create login facilities for field people/assistants.
 - b. If CSC has got front end software already developed to cover all activities expected to be done by them on ER operation and EVP related activities, then a single API can be given for connecting the software with central database through ERO Net. In this case it is to be ensured that in CSC software there is no provision for catching data for local storage by any means.
 - e. If such software is not available with CSC, login can be created on NVSP for each of the operators of CSC, the list of which will be authorized and provided by CEO to ECL
- 4. The API service have already been prepared and are available, therefore as soon as suitable recommendations are received from CEOs, it can be provided immediately.
- 5. The testing is must.

In case of CSCs are not existing in the State for some reason CEO refer to provide such services to citizen through other equivalent units such as e-mitra, e-seva Kendra or any other State level facilitation centres, the similar mechanism would be used. Yours sincerely.
