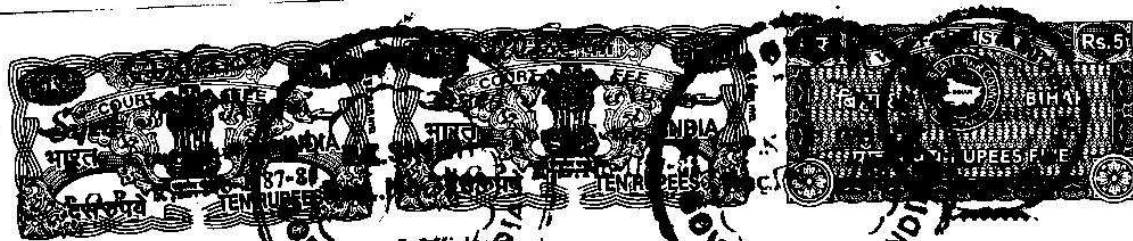

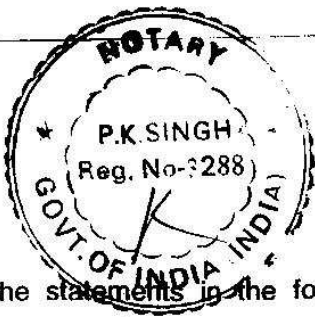
(1) That I was a contesting candidate at the general election/bye election to the House of the People/
