Legislative Assembly of 155 Kahalgachhi from Bhagalpur Parliamentary/Assembly constituency, the result of which was declared on 24.11.2010

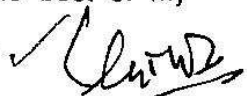

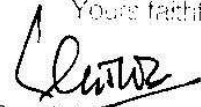
