As you are aware, nine Working Groups (WGs) were formed during the Conference of Chief Electoral Officers (CEOs) of all the States/UTs, held at New Delhi on 03 June 2019. Each of these Groups addressed certain thematic aspects of the recently concluded General Elections (GE) – 2019. Working Group – 8 (WG-8), dealt with the theme of 'Training and Capacity Building'.

- Subsequent to several intra-group deliberations and external consultations, WG-8 came out with a set of interim-recommendations. Among several other recommendations, special emphasis was laid on 'Trainers Quality', specifically on selection of NLMTs and SLMTs. The Group has proposed dynamic up-gradation of trainers by graduating the SLMTs to NLMTs. In line with the recommendations, it has been decided to identify and select SLMTs who have shown excellent performance in General Elections (GE) 2019, with the potential to become NLMTs and after due process absorb them into the NLMT resource pool.
- 3. Towards this end, the CEOs are requested to nominate 3 trainers from their State/UT SLMT resource pool, who possess the potential to perform at the national level and can be elevated as NLMTs. The nominated SLMTs will go through a screening process following which their progress will be monitored and after due evaluation will be graduates NLMTs. CEO's may also nominate Resource Persons from retired officers, provided they have participated in training efforts in GE 2019.
