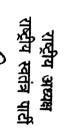

ACCOUNTING POLICIES

- Method of Accounting:- The accounts are maintained on historical cost basis and generally acceptted accounting principles. The merchantile system of accounting is adopted and accounts are prepared as going concern and there is consistency in accounting policies as compared to earlier year.
- 2 Method of Depreciation:- Depreciation has been charged on written down value (W.D.V.) method as per Income Tax Act, 1961.
- **Valuation of Inventories:** Not Applicable
- Valuation of the Fixed Assets:- The fixed assets are shown at cost less depreciation. None of the fixed assets is revalued during the year.
- **Contingent Liabilities:** The Party has neither given any gurantee nor excepted to incure any excepted liability. At present, there is no contingent liability in nature at all as stated by the Trustees.
- 6 No retirement benefit scheme is adopted by the Trustees for their employee.
