Subject: **Submission of details in respect of Electoral Bond(s)-Hon'ble Supreme Court Order dated 2<sup>nd</sup> November, 2023-Reg.**

Madam/Sir,

Your attention is invited to the Order passed, dated **02.11.2023**, by the Hon'ble Supreme Court in the case of Association for Democratic Reforms Vs Union of India, (Writ Petition(s) (Civil) No(s).880/2017). As you may be aware, the Hon'ble Supreme Court has directed that all political parties should give particulars of Electoral Bonds, received by them till 30.09.2023, in sealed cover, to the Election Commission of India, containing particulars as directed in Hon'ble Supreme Court's interim order dated 12.04.2019 in the same case (writ petition civil no. 333 of 2015 with 880 of 2017, 59 of 2018 and 434 of 2018).

2. All such parties, which have ever received any donation by way of Electoral Bond(s), since the inception of the Electoral Bond Scheme, are to furnish the details of all such donation(s) received by them, by way of Electoral Bond(s) till 30.09.2023, along with detailed particulars of the donors against each bond; the amount of each such bond and the full particulars of the credit received against each bond, namely, the particulars of the bank account to which the account has been credited and the date of each such credit.

3. The above particulars, in double sealed cover, i.e. two sealed envelopes (one duly sealed envelope containing the particulars and second duly sealed envelope containing the first envelope), are to be addressed to:-


4. Such sealed cover should reach the Commission latest by **5:00 PM, 15.11.2023**. The envelope should be clearly marked as "**Confidential-Electoral Bond**". The name of the political party, submitting the information, must also be clearly written on the envelope.
