Ltd., Chennai was opened on 25.04.2025 at 03:00 PM to prepare the list of L1 and L2. After financial evaluation Madras Security Printers Pvt. Ltd., Chennai and Manipal Payment & Identity Solutions Limited, Karnataka have been found to be L1 and L2 respectively. The rate quoted by Madras Security Printers Pvt. Ltd., Chennai is ₹8.42 per unit (exclusive of all taxes) whereas the rate given by

Manipal Payment & Identity Solutions Limited, Karnataka is ₹9.85 per unit (exclusive of all taxes).
